## MEMORANDUM OF ASSOCIATION AND RULES AND REGULATIONS OF THE ROMAN CATHOLIC DIOCESE OF TELLICHERRY.

MEMORANDUM OF ASSOCIATION OF THE ROMAN CATHOLIC DIOCESE OF TELLICHERRY.

- 1. The name of the Society is "THE ROMAN CATHOLIC DIOCESE OF TELLICHERRY".
- II. The object for which the Society is established are the promotion of Literature and Science, the diffusion of useful knowledge, and charitable purpose The means employed for the attainment of these objects are:-
- a) The provision and maintenance of Colleges, High Schools, Secondary Schools, Primary Schools, Industrial Schools, Agricultural farms, Orphanages, Dispensaries, Churches and other charitable institutions belonging to the Diocese of Tellicherry.
- b) The supply and maintenance of professors and teachers therefore and of books and other necessaries incidental to the carrying out of such educational ventures as may from time to time seem good and necessary in the estimation of the Governing Body and in accordance with the Madras Educational Code.

## RULES AND REGULATIONS OF THE ROMAN CATHOLIC DIOCESE OF TELLICHERRY.

- 1. MEMBERSHIP:— The membership will be open only to the Catholic Clergy of the Diocese of Tellicherry residing within the jurisdiction of the Diocece. The members of the Society shall consist of the subscribers to the Memorandum of Association and those who after admission as hereinafter provided shall sign the roll of members. Each member shall contribute Rs. 1000/— or more to the Society.
- 2. ENTRANCE FEE:— Each member shall pay an entrance fee of Rs. 2/on admission.
- 3. THE GOVERNING BODY:— The Governing Body shall consist of a chairman and four councillors. The Ordinary of the Diocese of Tellicherry shall be the ex-officio Chairman of the Governing Body. In the absence of the Ordinary the Vicar General Shall officiate as Chairman. From among the Councillors the Chairman shall appoint a Secretary and a Procurator.
- 4. THE CHAIRMAN of the Governing Body will be at liberty to remove at his discretion any member of the Governing Body without assigning any reason therefor.
- 5. IN THE EVENT OF ANY VACANCY occurring among the members of the Governing Body either upon a transter, resignation or death, such a vacancy shall be filled by the Chairman after having heard the opinion of the remaining members of such Governing Body within three months from the date of such vacancy.
- 6. ANNUAL MEETINGS:— At least one meeting of the Governing Body shall be held each year. At all such meetings of the Governing Body three members shall form a quorum. The General Body also shall meet at least once in the year and the quorum will be formed by four. In both the Governing Body Meeting and the General Body Meeting the Chairman shall have a casting vote.
- 7. ALL APPLICATION for membership shall be placed before the Governing Body and no one shall be admitted unless his admission is approved by the majority of the members present.
- 8. The Governing Body may meet for the despath of business, adjourn or otherwise regulate its business as it thinks fit.
- 9. BUSINESS OF THE SOCIETY:— The Management of the affairs of the Society shall be entrusted to the Governing Body who shall do everything which in their opinion is necessary for the purpose of carrying out the objects of the Society.
- 10. IN THE EXERCISE OF ITS FUNCTIONS the Governing Bady shall be governed in all matters by the provision of Cannon Law.
- 11. IN ALL TRANSACTIONS the Society shall be fully represented by the Procurator who shall demand and receive all money due to the Society and give proper receipts for the same.
- 12. THE PROCURATOR shall on behalf of the Society execute all documents and make all endorsements as may be necessary for the purpose of assigning or creating an interest in or in respect of any property of the Society whether movable or immovable, or for negotiating any note, bill or other security belonging to the Society or generally for the purpose of carrying on the business of the Society.

- 13. The Socity shall also be fully represented by the Procurator in all Judicial proceedings before any civil, criminal or revenue court, or before a Registrar or Sub-Registrar of assurances.
- 14 The Governing Body shall have the power to mortgage, sell, lease, gift or otherwise deal with the properties of the Society movable or immovable.
- of three of its members to make, vary, or repeal the rules and regulations of the Society if deemed necessary.
- 16. All the properties both movable and immovable and all securities belonging to the Society shall rest in the Governing Body of the Society.
